Voting will be open for thirty (30) minutes following the conclusion of the meeting.

If you are casting a vote as a proxy for another homeowner, please send that vote in a separate email with the address of that homeowner in the subject line. The body of the email should say "YES" or "NO" with your name typed at the bottom (not the name of the homeowner in which you are voting for). Proxy votes will only be counted if a proxy is received by the management company by October 16, 2020.
